Roles & Responsibilities

- Management will provide resources, leadership and oversight to support environmental performance.
- Employees will follow environmental procedures, report hazards and support pollution prevention.

Leadership & Culture

- Promote and communicate this Environmental Policy to all personnel.
- Enhance employee awareness, training and competence in environmental responsibilities.
- Empower employees to identify and implement innovative, sustainable solutions.

Environmental Risk Management

- Continually improve the identification and management of environmental risks and opportunities.
- Implement effective planning, control measures and emergency response arrangements to prevent environmental incidents.
- Protect biodiversity, local ecosystems and surrounding communities.
- Implement erosion and sediment controls during excavation to prevent soil, debris or pollutants entering stormwater systems.

Pollution Prevention & Resource Efficiency

- Prevent pollution and minimise waste.
- Use licensed and environmentally responsible contractors for disposal of liquid waste and regulated materials.
- Promote and install water-efficient plumbing products.
- Reduce paper usage through digital systems, online documentation and electronic signing solutions.
- Ensure that no waste, chemicals, sediment or wash-out materials enter stormwater drains, pits or waterways.
- Ensure all sewage, trade waste and drainage work is contained, prevented from spilling, and disposed of in accordance with regulatory requirements.
- Store, handle and dispose of plumbing related chemicals to avoid spills and environmental contamination.
- Recycle metals, hot water units, tapware, pipe offcuts and other plumbing fixtures where feasible to reduce landfill waste.

Water Conservation

- Minimise water wastage during plumbing repairs, testing, commissioning and flushing activities.

Energy, Emissions & Climate

- Reduce energy consumption where possible.
- Support climate change mitigation and adaptation initiatives.
- Promote sustainable alternatives such as solar solutions.
- Transition our fleet to hybrid or low-emission vehicles where feasible.
- Promote energy-efficient hot water technologies such as heat pump or solar hot water systems where suitable.

Sustainable Procurement

- Consider environmental impacts when selecting materials, equipment, suppliers and subcontractors.
- Engage contractors and partners who demonstrate responsible environmental performance.

Noise & Community Impact

- Minimise noise impacts from plumbing equipment and tools, especially in residential or sensitive environments.

- Monitor, audit and report environmental performance to ensure transparency.
